EXPRESSION OF INTEREST (EOI) EMPANELMENT OF PROFESSIONAL FIRM FOR SUPPLY AND SETTING UP OF PREFABRICATED CONTAINERS/STRUCTURES AROUND MEGHALAYA

. Introduction:

With the rising tourist footfall in Meghalaya, it is necessary that provisions be made for wayside amenities along the prominent routes in the State. These will include restaurant, toilets, cafes, other conveniences and will be built in a prefab mode. This will provide the tourists, the passengers and the drivers certain minimum standards for public conveniences and wayside facilities to make their travel safe, comfortable and convenient. This will also help generate livelihood opportunities in the local economy. The proposed facilities shall be built using **standard logistics containers** or any other suitable **prefab structure**.

In this regard EOI has been issued to invite applications from eligible and interested professional firms / agencies for Empanelment of the firm with the Tourism Department in supplying and installing of Standard Logistics prefab containers /structures.

2. Procedures of Empanelment:

A. SCREENING

Screening of the EOIs received

B. SHORTLISTING

i. The Department of Tourism shall short list only the eligible applicants who meet the basic requirements as specified in this document.

C. EVALUATION

Final evaluation of the applicants shall be done by the State Level Selection Committee (SLSC) headed by Director of Tourism. The SLSC will comprise of the following members:

- 1. Director of Tourism, Government of Meghalaya Chairman
- 2. Director, Meghalayan Age Limited Member
- 3. Chief Administrative Officer, Meghalayan Age Limited Member
- 4. Executive Engineer, Tourism Department.

3. Qualifying Criteria

- 1. The agencies/ firms applying for this EOI should meet the following criteria:
 - a. Financial standing: The firm should have an annual turnover of at least Rs. 2 crore consecutively for the last three financial years i.e. 2019-20, 2020-21, 2021-22 as per duly certified/ audited by a chartered accountant.
 - b. Capabilities: The firm should have high engineering design and execution capabilities and a team of experienced staff for setting up of Prefab structure. The firm should have high expertise in designing, fabrication & installation of prefabricated Structures.
 - c. Experience: The firm should have experience in supply and installation of prefabricated structures to Government Department/agencies.(Work Order copies shall be enclosed along with the EOI). Preference will be given to those

that has experience in setting of prefab with materials that are suitable for

d. Technical team: The firm should have a dedicated and experienced team. (List of technical personnel to be enclosed along with this EOI)

e. The firm should submit the Firm's PAN No and GST certificate.

Documents to accompany EOI

The applications shall be complete with the following documents:-

- a) Each page of the EOI document should be duly stamped and signed by the applicant.
- b) Form I (Annexure 1) Information of the Applicant
- c) Self-declaration in Form II (Annexure 2)
- d) Format for Pre-bid queries in Form III (Annexure 3)
- e) Supporting documents as per Qualifying criteria.

Technical Specification

- The agency shall undertake the work of setting up of prefab containers/structures in the locations specified across the state of Meghalaya as per the requirements.
- 2. The final locations shall be shared with the shortlisted candidates. However, they will be spread across the State. Hence, the firms should consider the varying climatic conditions while preparing designs. The climatic conditions vary from very high rainfall to extreme cold (sub-zero) to maximum temperatures ranging up to 35-40° C.
- 3. The design of prefab structure should be inclusive of electrical, civil, sanitary and plumbing fitting
- 4. The firm may submit different designs for café/restaurant, toilets, kiosks etc.
- 5. The agencies shall execute the work of setting up of the prefab Structures specified as per the structural design.
- 6. The tentative dimensions for the structures can be
 - a. 10' * 8' * 8'6"
 - b. 10' * 20' * 8'6"
 - c. 10' * 40' * 8'6"
- 7. As per requirements in different locations of the state, the technical specifications are as follows:
