2. Introduction

The Directorate of Tourism is responsible for the development of tourism related facilities in the State of Meghalaya.

For this purpose, the Directorate of Tourism invites Communities who own land in Meghalaya which is located in existing tourism / potential tourism spots to make available / provide the land parcel by lease deed or gift deed (Gift deed is the preferred mode) to the Directorate of Tourism, Government of Meghalaya.

The purpose of the taking land parcels from the Communities is for the development of tourism infrastructure on the land parcels comprising of wayside amenities, restaurants / cafes, public conveniences, accommodation facilities such as guest houses, hotels, etc.

Salient features:

- The Community shall ensure that the land parcel being provided to the Directorate of Tourism, Government of Meghalaya, through lease deed or gift deed, is free from all encumbrances.
- ii. The Directorate of Tourism, Government of Meghalaya, shall develop the tourist infrastructure on the land parcels and invite operators from the private sector for the operation and maintenance of the tourist infrastructure.
- iii. The private sector operator shall pay a rental fee towards the operation and maintenance of the developed tourism infrastructure to the Directorate of Tourism, Government of Meghalaya, on a monthly basis.
- iv. The Directorate of tourism will **share a portion of the rental** to the Community which provided the land.

Those desirous of participating in the Expression of Interest for provision of land parcels to the Directorate of Tourism, Government of Meghalaya, are required to provide the details of as specified in Annexure-1 and Annexure-2.

Pre-qualification criteria

The Directorate of Tourism shall evaluate only those applications which fulfil the following criteria:

- a) The applicant shall be permanent resident of Meghalaya
- b) The applicant should be the owner of the land parcel and provide ownership documents as evidence.
- c) The land parcel must be located in an existing tourism / potential tourism spot.

5. EOI Submission

Applicants shall submit the Expression of Interest to the Directorate of Tourism, Government of Meghalaya by submitting Expression of Interest (Annexure 1), Details of the Applicant (Annexure 2) and any other relevant document.

6. Final selection of land parcels

Final selection of the land parcels shall be conducted by the Directorate of Tourism based on the location and potential utilization of the land parcel for the purpose of tourism.

7. Clarifications and Amendments

For any request received for clarification of this EOI document, the response with any amendment to this document shall be posted on the website http://www.meghalayatourism.in for information of all the applicants. Applicants are advised to visit the website, for any amendments to the Terms and Conditions, change of dates and for Award of Applications.

8. Submission Guidelines

(i) Sealing of Envelopes and Submission

EOI should be submitted (duly signed on all the pages) on or before the mentioned last date. The Directorate of Tourism reserves the right to reject any or all the EOIs without assigning any reasons.

(ii) Documents to accompany EOI

The applications shall be complete with the following documents:

- a) Expression of Interest in Annexure 1
- b) Details of applicant in Annexure 2
- c) Proof of ownership
- d) Pan card

(iii) Validity of EOI

EOI shall remain valid for a period not less than 60 days after the deadline date specified for submission.
