## **PRESS RELEASE**

The Government of Meghalaya, Tourism Department, has mandated an online data collection process for all accommodation providers (hotels, guesthouses, homestays, bed and breakfast establishments, etc.) in Meghalaya vide Office Memorandum No. Tourism /5/2021/43 dated 24<sup>th</sup> January 2024.

This online process facilitates daily check-in and check-out data recording, including details such as visitor numbers, gender, state/country of origin, and identity proof/visa/C-form uploads.

Due to security concerns, all accommodation providers are requested to kindly obtain No Objection Certificate from the District Administration and District Police.
